

# **Leisure and Cultural Services Department One-off Grant to Registered Sports Coaches Guides to Application**

## **1. Brief description**

1.1 Due to the epidemic situation, the sports venues under the Leisure and Cultural Services Department (LCSD) as well as the venues of schools and sports organisations are closed, and most of the recreation and sports programmes have been cancelled. This has greatly affected the coaches whose income depends on sports coaching. In addition, many coaches on the market are employed by non-governmental organisations and schools, or self-employed to provide private coaching lessons. As such, the Government will extend the Anti-epidemic Fund to cover coaches registered under National Sports Associations (NSAs) or recognized Sports Organisations (SOs) <sup>Note</sup>. A one-off grant of \$7,500 will be released to the registered coaches who have been in active service (provision of supporting documents required) in the past year.

1.2 The LCSD will implement the One-off Grant to Registered Sports Coaches (the Scheme) via NSAs and recognised SOs. NSAs/SOs will be responsible for assessing the eligibility of applying coaches (including whether they are registered with the NSAs/SOs). The eligible registered coaches will be asked to make the following declarations:

- a. they have been coaching in the past year (1 April 2019 to 31 March 2020);
- b. they have not applied for the Scheme by using registered coach status of other NSAs/SOs; and
- c. they have not applied for the relief grant administered by the Education Bureau (EDB) and the Labour and Welfare Bureau (LWB)/Social Welfare Department (SWD) for interest group/class instructors under the second round Anti-epidemic Fund.

## **2. Eligibility**

The applicant must:

- be a Hong Kong resident; and
- be a registered coach of NSAs under the Sports Federation and Olympic Committee of Hong Kong, China (SF&OC) or recognised SOs at Annex I; and
- submit supporting documents showing that the applicant has provided coaching service in the past year. Applicants who are self-employed should make a declaration in the application form regarding the provision of coaching service.

## **3. Application Period**

- 15 May to 15 June 2020
- LCSD will not issue acknowledgment to applicants.

**Note :** Recognised SOs refers to SOs that are receiving project-based subvention from the LCSD's Sports Subvention Scheme.

## 4. Application Procedures

4.1 Applicants can refer to the procedures below for application for the grant:

### Confirmation of Eligibility

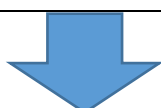
The applicant must:

- be a Hong Kong resident;
- be a registered coach of NSAs under the SF&OC or recognised SOs;
- possess supporting documents showing that the applicant has provided coaching service in the past year (applicants who are self-employed should make a declaration in the application form regarding the provision of coaching service); and
- not have applied for other one-off relief grants under the second round Anti-epidemic Fund.



### Completion of Application Form

- Fill in all the information required in the application form.
- For submission by post, the applicant shall attach a copy of his/her Hong Kong Identity Card for verification. The copy will be destroyed afterwards.
- If the application is approved, the grant will be delivered to the applicant by cheque. Please fill in the return address clearly and accurately to avoid misdelivery.
- Provide work-related supporting documents. Applicants who are self-employed should make a declaration in the application form regarding the provision of coaching service.
- Make the declaration in the declaration section and **sign** to confirm that all the information given is true and correct. Otherwise, the LCSD will not be able to process the application.
- Understand and agree with the content of the Personal Information Collection Statement.



### Submission of Application Form

- Applications can be submitted:
  - i. by post with relevant documents to the Sports Funding Office, 3/F, Leisure & Cultural Services Department Headquarters, 1-3 Pai Tau Street, Shatin, New Territories; or
  - ii. in person at any District Leisure Services Offices of LCSD. Please refer to the LCSD's website (<http://www.lcsd.gov.hk>) for detailed addresses.
- Please mark on the face of the envelope **“One-off Grant to Registered Sports Coaches.”**

4.2 Application forms can be downloaded from the LCSD's website (<http://www.lcsd.gov.hk>) or obtained from District Leisure Services Offices.

## **5. Arrangement on the release of the grant**

In general, an applicants will be notified of the result by SMS about one month upon receipt of the application. The grant will be released to successful applicants by cheque.

## **6. Assessment and other matters**

6.1 All applications are handled by the Sports Funding Office of the LCSD. The office reserves the right to determine the arrangement and result of the application.

6.2 All amounts quoted in this Guide to Application are in Hong Kong dollars.

## **7. Personal Information Collection Statement**

### **7.1 Purposes of Collection**

The personal data<sup>1</sup> supplied will be used by the LCSD and the NSAs/ SOs commissioned by the Government to process the applications for the One-off Grant to Registered Sports Coaches, including but not limited to assessing and/or investigating your eligibility under the Scheme, monitoring and reviewing of the Scheme, handling of complaints related to the Scheme, conducting research and survey, preparing statistics, and discharging statutory duties. The provision of personal data to the LCSD is voluntary. However, if you fail to provide the personal data requested of you, the LCSD may not be able to process your application.

### **7.2 Classes of Transferees**

The personal data you provide will be made available to persons working in/for the LCSD on a need-to-know basis. Apart from this, the data may be disclosed to the parties or in the circumstances listed below for the purposes mentioned in paragraph 7.1 above:

- (a) Other parties (e.g. the EDB, Home Affairs Bureau, LWB, SWD, NSAs/SOs, etc.) if they are involved in:
  - i. processing and/or assessing any application from you to the LCSD mentioned in paragraph 1 above;
  - ii. the provision of assistance to you by the LCSD mentioned in paragraph 7.1 above; or
  - iii. monitoring and reviewing of your application to the LCSD mentioned in paragraph 7.1 above or preparing statistics<sup>2</sup>;

<sup>1</sup> Under the Personal Data (Privacy) Ordinance (Cap. 486) , personal data means any data –

(a) relating directly or indirectly to a living individual;

(b) from which it is practicable for the identity of the individual to be directly or indirectly ascertained; and

(c) in a form in which access to or processing of the data is practicable.

<sup>2</sup> The statistics or the research results obtained will not be released or made available to a third party in a form that identifies the data subjects or any of them.

- (b) Complaint handling authorities such as the Office of the Ombudsman, the Office of the Privacy Commissioner for Personal Data, the Legislative Council, etc. if they are handling complaints about the Scheme;
- (c) Where such disclosure is authorised or required by law; or
- (d) Where you have given your prescribed consent to such disclosure.

### 7.3 Access to Personal Data

You have the right to request access to and correction of your personal data held by the LCSD in accordance with the Personal Data (Privacy) Ordinance, Cap 486. A fee is charged for supplying copies of personal data. Requests for making access to and correction of personal data collected by the LCSD should be addressed to –

## 8. Declaration

The application form must be signed by the applicant to indicate and guarantee that all information given in the form is true and correct to the best of his/her knowledge. For applicants below the age of 18, the declaration should be signed by their parents or guardians aged 18 or above to guarantee their liability for the applications. Any false statement will render the application invalid. Any person who knowingly makes a false statement is liable to prosecution.
