Membership of The Hong Kong China Skating Union Limited (the "Union") is opened to any legitimate Hong Kong resident who is healthy, of rightful character and conduct and is willing to abide by the Constitution of the Union, observe its resolutions, disciplinary codes and membership fee payment schedule. No application fee will be charged in applying for membership. 2. Applicants for membership with the Union should truthfully fill in this form for approval. The Annual Subscription payable upon admission as a member and subsequently on the 1st day of each calendar year commencing from the 1st day of the year in which the member is admitted. For fee details, please refer to the Articles of Association of the Union. Any member who procrastinates payment of due membership fee shall be seen and treated, without prior notice from the Union, as withdrawal from membership. 3. The Union is a non-profit-making organization for amateurs, if any member who withdraws from the Union, all fees paid by the member during membership will not be refunded. 4. Under Constitutions of the International Skating Union, no member of the Union shall in the meantime enroll as member of other organizations of similar nature nor can he/she take part in activities thereof. Any member participating activities of organizations other than the Union without the agreement from the Union shall be seen and treated as withdrawal. 5. All members of the Union should observe the laws of Hong Kong, abide by social morality and by all means preserve the goodwill of the Union through solidarity, mutual assistance, encouragement and advancement. Responsibilities for any incidents or violation of law shall be borne by the individual member whereas the Union and its affiliated Associations shall be exempted from whatsoever liabilities. The Union has the absolute right to terminate the membership of any member who has committed wrongdoing without having to render any reasons or explanations thereto. 6. Members should pay attention to personal safety and self-insured when taking part in any activities organized by the Union. Incidents occurred or injuries inflicted shall be the responsibilities of the parties involved whereas the Union and its affiliated Associations shall not be held responsible for whatsoever liabilities, legal or economic loss, arising therefrom. 7. This application form should be filled in with correct information in neat print while applicants are reminded to peruse these notes and the Constitution of the Union carefully. 8. The Union reserves the absolute right to refuse any application. 9. I _____, the above signed hereby undertake from time to time to abide by and support the anti-doping policy of the International Skating Union, the Sports Federation & Olympic Committee of Hong Kong, China, the Hong Kong Anti-Doping Committee, the Leisure and Cultural Services Department, the Union and other Government Departments.
